

ORDINANCE NUMBER 4-90

AN ORDINANCE EXTENDING THE CITY LIMITS OF THE CITY OF HAHIRA,
GEORGIA.

BE IT ORDAINED by the Mayor and Council of the City of Hahira and it is hereby ordained by the authority of same, and pursuant to, in accordance with, and by the authority granted to municipalities by the Georgia General Assembly pursuant to Georgia Law 1962, page 119, as amended, the following described lands, being contiguous to the City of Hahira, are hereby annexed to and incorporated in the corporate limits of the City of Hahira, Georgia, to wit:

All that tract or parcel of land situate, lying and being in Land Lot No. 96 of the 12th Land District, Lowndes County, Georgia, and being more particularly described as follows: As a point-of-reference only commence at the point of intersection of the South right-of-way of State Route 122, and the West right-of-way of Frontage Road, and from said point-of-reference run along the West right-of-way of Frontage Road South 25 degrees 30 minutes East 351.41 feet to a concrete monument; thence continue along said right-of-way South 32 degrees 11 minutes 00 seconds East 570.10 feet to the Point-of-Beginning. From said Point-of-Beginning continue along said right-of-way South 32 degrees 11 minutes 00 seconds East 183.70 feet to a concrete monument; thence continue along said right-of-way South 16 degrees 34 minutes 00 seconds East 216.30 feet to a point; thence leaving said right-of-way run South 73 degrees 26 minutes 00 seconds West 200.00 feet to a point; thence run North 23 degrees 38 minutes 00 seconds West 341.98 feet to a point; thence run North 57 degrees 49 minutes 00 seconds East 200.00 feet to the Point-of-Beginning. The above described tract or parcel of land contains 1.802 acres, and is shown on the plat by Charles M. Harris, Surveyor dated 4-19-90, which plat by reference hereto is made a part of this description.

And the same is hereby zoned and classified CH Zoning Classification. The official zoning map of the City of Hahira is also amended and modified in accordance with the provisions of this ordinance.

The aforesaid property is annexed with the specific stipulation that no sewer service is available to the annexed property at the time of annexation.


