

ORDINANCE NUMBER 3-92

AN ORDINANCE EXTENDING THE CITY LIMITS OF THE CITY OF HAHIRA,
GEORGIA.

BE IT ORDAINED by the Mayor and Council of the City of Hahira and it is hereby ordained by the authority of same, and pursuant to, in accordance with, and by the authority granted to municipalities by the Georgia General Assembly pursuant to Georgia Law 1962, page 119, as amended, the following described lands, being contiguous to the City of Hahira, are hereby annexed to and incorporated in the corporate limits of the City of Hahira, Georgia, to wit:

All that tract or parcel of land situated, lying and being in Land Lot 50 of the 12th Land District of Lowndes County Georgia, for a point of reference only, beginning where the northernmost portion of Lot 1 of PINE FOREST SUBDIVISION intersects the eastern right-of-way of Hagan Bridge Road as is reflected in that certain plat or survey of Pine Forest Subdivision, recorded in Plat Record Book F. page 169 of the Lowndes County Plat Records, and from said point, running thence north 88 degrees 38 minutes 15 seconds east a distance of 290.69 feet to a point; thence continuing north 88 degrees 38 minutes 15 seconds east a distance of 213 feet to a concrete monument and our POINT OF BEGINNING. From said POINT OF BEGINNING running thence north 88 degrees 38 minutes 15 seconds east a distance of 150.68 feet to an iron pipe; thence continuing north 88 degrees 38 minutes 15 seconds east a distance of 1,155.95 feet, more or less, to a concrete monument; thence running south 28 degrees 18 minutes 25 seconds east a distance of 309.30 feet to an iron pipe; thence south 2 degrees 30 minutes 22 seconds west a distance of 457.46 feet to an iron pipe; thence north 89 degrees 6 minutes 55 seconds west a distance of 1,275.54 feet, more or less, to an iron pipe; thence north 35 degrees 00 minutes 31 seconds a distance of 399.28 feet to the southernmost right-of-way of Claudia Drive; thence continuing north 35 degrees 00 minutes 31 seconds west 50 feet, more or less, to a concrete monument located on the northernmost right-of-way of Claudia Drive; thence north 8 degrees 27 minutes 20 seconds west a distance of 302.5 feet to our point of beginning.

And the same is hereby zoned and classified R-15 Zoning Classifica-

tion. The Official Zoning Map of the City of Hahira is also amended and modified in accordance with the provisions of this ordinance.
