Some of the chairs do have rips in them, the courts do not use this courtroom anymore so we are the only ones using the chairs now. Councilman Warren said that he thinks we should stick with this chair with the embroidery on it, we have a good price for replacement chairs. **Councilman Warren made a motion to approve the purchase of the new chairs with embroidery at quoted price which was seconded by Mayor Pro Tem Barfield. Councilman Warren, Councilman Davis and Mayor Pro Tem Barfield all voted in favor of the motion.**
