The Mayor and Council met for a Council meeting at the Courthouse with Mayor Bruce Cain presiding.

COUNCIL ELECTION-MAYOR PRO TEM:

The Mayor stated it is the beginning of the year and time to elect Mayor Pro Tem for 2019. A motion was made by Councilman Warren to nominate Councilman Davis as Mayor Pro Tem which was seconded by Mayor Pro Tem Barfield. Councilman Davis, Councilman Warren and Mayor Pro Tem Barfield all voted in favor of the motion.

REVIEW/CORRECTION OF MEETING MINUTES:

The Mayor asked if anyone had any questions or corrections regarding the minutes. None noted. **Councilman Barfield made a motion to approve the minutes as presented which was seconded by**

Mayor Pro Tem Davis. Councilman Barfield, Councilman Warren and Mayor Pro Tem Davis all voted in favor of the motion.

CITIZENS TO BE HEARD:

Mark Lampert of 550 W. Stanfill Street B-14 stated he was here regarding the traffic going so fast on Main Street. He said it is hard to cross the road or back out in this area. Is there anything we can do to lower the speed limit to 25 miles per hour in the downtown area? He also said he is excited about 2019 and that the citizens are wondering about what has been prepared regarding the Park area and what new hotels and eateries are coming into town now that I-75 is almost complete.

REVIEW OF BILLS/BUDGET OVERAGES:

The Mayor asked if anyone had any questions or corrections regarding the bills. None noted. Mayor Pro Tem Davis made a motion to pay the bills as presented which was seconded by Councilman Warren. Councilman Barfield, Councilman Warren and Mayor Pro Tem Davis all voted in favor of the motion.

DISCUSSIONS:

A. BILLBOARDS (CHRIS HAMILTON-V-LCCC&TA)

Emily Davenport stated she has been working with Chris Hamilton with the Valdosta LCCC & TA. We have had the same billboards on I-75 for the past two years and they have not changed. Chris Hamilton had the idea that the Tourism Authority could take them over and I think this would be a great partnership. Chris Hamilton stated that he thinks this will be a win-win situation. It would commit Hahira messages and give significant access to the City of Hahira. We need the space, we take over the expenses. We would be working with Emily and partner with Mayor/Council to be sure it would be what the City would want on I-75. The Mayor stated that he liked the idea, keep it two boards Hahira specific, one north bound and one South bound. Councilman Barfield said so would Emily be involved and Chris Hamilton stated yes we will work side by side. The Council would see the designs before message is put out there. The Mayor asked if anyone had any questions. None noted. He stated that in the packet you have four options. Emily recommends option 3 which would authorize the Tourism Authority to take over the billboards. City Manager Sumner said he would like to thank Chris Hamilton and his staff for the great work they do and for working with our staff. It is nice to identify partnership with cities, Emily can continue to work with Chris and we are appreciative. Councilman Barfield made a motion to accept option three which was seconded by Councilman Warren. Councilman Barfield, Councilman Warren and Mayor Pro Tem Davis all voted in favor of the motion.
